The two largest expenditures were a check to Sheila for \$149.90 for reimbursement for procuring the .com address for the regional website for ten years and a check to GIS in the Rockies for \$75.00 for presenter sponsorship at the 2006 conference.

4. National Directors Report:

Plans for Pecora 2008 in Denver are moving forward. James Sturdevant from EROS is the Steering Committee Chairman. Allen will continue to serve as the interim contact for our region but he requested that we begin considering a permanent replacement to serve in the position. The National Board has signed a contract for the 2010 Annual Conference in San Diego after receiving a favorable offer from the City and County of San Diego.

ASPRS is increasing the value of scholarships. As the ASPRS Foundation continues its successful program to fully endow all scholarships, both the value and frequency of scholarships awarded at the National level are gradually increasing.

5. Newsletter Status/Issues:

Jen sent an e-mail to Jeff indicating that the newsletter will be issued soon. Jeff reiterated the need to begin looking for a replacement for Jen who will not be able to serve next year due to her relocation to another region.

6. GIS in the Rockies:

Jeff and Victoria have filled the positions vacated by Roland and Trent on the GIS in the Rockies Planning Committee. Victoria secured a larger room for the ASPRS Track during the walk-through to accommodate the large number of participants. GIWIS (www.giwis.org) will be launched at the GIS in the Rockies Conference. The ASPRS Track has been filled successfully.

7. Membership Outreach:

8. Annual Scholarships:

Jeff made a call of action to revise the criteria for scholarships. Jeff and Terry will work together to draft the criteria and will circulate among board members for approval. The amount of the regional annual scholarships fluctuates dependent upon circumstances. The largest amount distributed was \$5000.00. Last year, \$3250.00 was awarded. Once the income has been received from the GIS in the Rockies Conference, the board will be able to determine the amount of scholarship money that will be awarded this year. Terry and Jeff will work on a strategy to get the scholarship announcement out earlier.

The issue of funding student travel was discussed. Students who are scholarship recipients may use the money for travel expenses to attend conferences but the region is not in a position to fund student travel to conferences outside the United States and ones not sponsored by ASPRS. Travel scholarships and financial assistance to the ASPRS Annual Meetings will be considered.

9. Website Update:

The domain registration for the ".com" address was registered with Network Solutions for 10 years for \$149.90. Now all www.asprs-rmr.com requests will be forwarded to the www.asprs-rmr.org URL.

Sheila has had difficulty contacting the web designer regarding the fix needed for the website banner and hopes to provide an update at the next meeting.

Sheila talked with Ken Turnbull about sponsoring the Rogues meeting in October. The sponsorship costs \$500.00 for the room and food. All were in favor and Jeff asked that we vote.
