Board Meeting Minutes

27 May 2014, 12:30-1:30 PM

- 1. Meeting **called to order** at 12:30 pm by Michaela.
- 2. **Roll call** was conducted and **no quorum** established. The meeting proceeded with a brief discussion of the 27 May 2014 **board meeting agenda** items but no voting.
